Invitation to the Summer School »Introduction to European Law«

JULY 28 – AUGUST 7, 2022

The law of the European Union plays an increasingly important role in business and legal practice, not only in the member states. **In the Summer School »Introduction to European Law«**, held in Wiesbaden in the heart of Europe, **you will gain a better understanding of European law and deepen your knowledge of the EU**. You will also meet students from Germany and other countries while getting to know the attractive Rhine-Main region, one of Europe's major business centres.

The **Wiesbaden Business School of the RheinMain University of Applied Sciences** would like to invite students from its partner universities to an English-language Summer School »Introduction to European Law«. It will take place from July 28 to August 7, 2022 on campus in Wiesbaden, Germany.

Prior to classes, participants will receive preparatory documents for advance self-study, and two video conferences (Webex) will introduce the topics and give initial homework assignments. **The Summer School corresponds to a workload of 3 ECTS credits on a semester basis and concludes with a written examination.** A certificate of performance will be issued.

Students pay a participation fee to attend. Students from abroad pay €300, which includes accommodation in a double room in a Wiesbaden hotel. WBS students pay €100, without hotel accommodation. Assistance with travel expenses (up to €300) to Wiesbaden is possible.

SPEAKERS OF THE SUMMER SCHOOL 2022

Prof. Dr. Markus Fischer

Prof. Dr. Markus Fischer LL.M. (London) teaches social law at the Department of Social Work at RheinMain University of Applied Sciences. He is the head of the Law and Management in Social Work (LL.B.) program and is also a theatre pedagogue (BuT).



MEP Michael Gahler

MEP Michael Gahler studied law in Mainz. After training at the German diplomatic school, he worked at the Foreign Office. He has been a Member of the European Parliament since April 1999. There he is, among other things, a member of the executive committee and foreign policy spokesman of the EPP parliamentary group. In addition, he is a member of the Foreign Affairs Committee and rapporteur on the implementation of the Association Agreement between the EU and Ukraine.



Prof. Dr. Friedemann Götting

Prof. Dr. Friedemann Götting is Deputy Managing Director of the Wiesbaden Chamber of Industry and Commerce and honorary professor at the RheinMain University of Applied Sciences, where he teaches European Law. He graduated in law from the University of Hamburg and later worked as a research assistant for the Institute for Maritime Law and Maritime Trade Law and at the University of Greifswald.



Prof. Dr. Marina Grusevaja

Prof. Dr. Marina Grusevaja teaches international business relations at the Wiesbaden Business School and heads the International Office. Over many years, she has carried out numerous educational assignments in Germany and abroad and has been actively involved in implementing international summer schools.



Prof. Dr. Michael Hakenberg

Prof. Dr. Michael Hakenberg studied law in Freiburg, Würzburg, and Ann Arbor, Michigan, and was a lawyer in Stuttgart and New York. From 1992 to 2018, he was Professor of German and International Business Law at Trier University of Applied Sciences.



Prof. Dr. Rainer Hartmann

Prof. Dr. Rainer Hartmann studied law in Freiburg/Breisgau. After some years in the private sector, he has been professor for tax, commercial and corporate law at the Wiesbaden Business School and a member of the Wiesbaden Institute for Law and Economics since 2010. In addition, he works as an independent tax advisor.



Prof. Dr. Britta Kuhn

Prof. Dr. Britta Kuhn teaches economics with a focus on International Economics at Wiesbaden Business School. She studied in Freiburg (Breisgau), Grenoble and Kiel, earned her doctorate at Mannheim University, worked for the management consultancy A.T. Kearney and at Bayerische Vereinsbank (later Hypovereinsbank).



Prof. Dr. Lidiia Moskvych

Prof. Dr. Lidiia Moskvych holds the Chair of Judicial Organization and Prosecutorial Activities at the Yaroslav Mudriy National Law University (Kharkiv, Ukraine). She holds degrees in Law and in Economics. Prof. Moskvych is an expert on legal issues in the field of judicial protection, including human rights.



Prof. Dr. Rainer Wedde

Prof. Dr. Rainer Wedde is professor of business law at Wiesbaden Business School and a member of the Wiesbaden Institute for Law and Economics. After studying law in Tübingen, Aix-en-Provence, Dresden and Freiburg (Breisgau), he worked as a lawyer in international law firms. He regularly publishes and lectures on international business law.
